Duties and key result areas:

- 1. Provide advice to Development Management officers and Planning Committees concerning the ecological implications of proposed developments to ensure compliance with relevant legislation and policy, and to further nature conservation in Northumberland.
- 2. Ensure compliance with Schedule7A of the Town and Country Planning Act through the assessment and monitoring of Biodiversity Net Gain schemes, securing amendments as required.
- 3. Instruct Legal Services concerning S.106 agreements and unilateral undertakings, and advise about queries and challenges to these raised by other signatories.
- 4. Provide advice concerning the conservation and enhancement of ecological resources through the strategic planning process for both the Local Plan and Neighbourhood Plans, to ensure compliance with relevant legislation and policy and to further nature conservation in Northumberland.
- 5. Assess proposals for Habitat Banks in Northumberland, secure amendments required to ensure that schemes are realistic and deliverable, and work with Legal Services to negotiate legal agreements for these
- 6. Monitor BNG sites and Habitat Banks over their lifetimes, securing actions required to address any problems and working with Legal Services to address any breaches
- 7. Prepare proofs of evidence for planning appeals ,and represent the Council at Hearings and Public Inquires
- 8. Produce briefs for assessments, studies and mitigation works necessitated by planning conditions and approve specifications for ecological work submitted by developers. Liaise with Development Management officers and developers to ensure the successful execution of work required by planning conditions to ensure that the terms of ecological based conditions are met prior to discharge of conditions.
- 9. Undertake Habitats Regulations Assessments for proposed developments and planning policy documents.
- 10. Provide advice concerning the conservation and enhancement of ecological resources during the working life, restoration and aftercare of minerals sites to ensure compliance with legislation, planning conditions and obligations and to further nature conservation in Northumberland.
- 11. Work with all Council departments managing land and property to ensure compliance with the legal duty to conserve and enhance biodiversity, and produce plans and reports for Government as required under S.40 of the Natural Environment and Rural Communities Act.
- 12. Provide advice concerning ecological matters to other parts of the Council as appropriate.

- 13. Answer enquiries from members of the public and other organisations.
- 14. Provide specialist officer representation on internal and external working and steering groups.
- 15. Work with internal and external partners to deliver projects to protect and promote the natural assets of the County.

The duties and responsibilities highlighted in this Job Description are indicative and may vary over time. Post holders are expected to undertake other duties and responsibilities relevant to the nature, level and extent of the post and the grade has been established on this basis.
