<p><b>Duties and key result areas:</b> Individually or as part of a team;</p> <ol style="list-style-type: none"> <li>1. Enable and promote independence, minimise intervention and attend to the needs of service users, maintaining a safe, hygienic and supportive environment in accordance with the culture, standards and objectives of the service.</li> <li>2. Communicate and report appropriately to service users, colleagues and senior staff. Assess and prioritise service user needs, with relevant senior staff, in order to determine care plans that are effective in meeting the needs of the individual.</li> <li>3 Act as link worker for nominated service users and contribute to the evaluation and review of the effectiveness of care plans.</li> <li>4 Work collaboratively with team colleagues to ensure that individual care plans are achieved and quality standards are maintained.</li> <li>5. Administer medication in accordance with instructions and service procedures.</li> <li>6. Maintain appropriate written records, in accordance with service remit and procedures. Attend Team meetings, training courses and participate in Appraisals and supervision, to improve own performance, as required</li> <li>7. Ensure that all interested parties are kept aware of nominated service users circumstances. Report any concerns/issues promptly to ensure effective intervention.</li> <li>8. Assist with personal care and practical support, the preparation and serving of meals, snacks, or beverages, laying and cleaning tables as required by service plans or service managers.</li> <li>9. Deal with contingencies and emergencies in accordance with established guidelines.</li> <li>10. Be aware of and comply with relevant legislation. Work within the parameters of County Council/ Northumberland Care Trust policies, procedures, guidance, CQC and National Standards and Codes of Conduct.</li> <li>11. Where necessary, the ability to drive all service vehicles, where it is a requirement of the service e.g. Minibuses.</li> <li>12. Other duties appropriate to the nature, level and grade of the post.</li> </ol>
